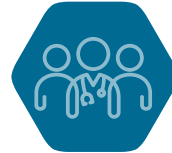

\*Members are required to join both the MMS and their local district medical society. The MMS membership cycle is based on the calendar year. Members may join at any time. Dues are not prorated.

#### Introductory Membership

Introductory State Dues	\$200
Introductory District Dues	\$50-\$125

#### Regular Membership

Standard State Dues	\$450
Standard   Family District Society Dues	\$50-\$200

#### CHC Employed Physicians

Physicians whose primary place of employment is a community health center recognized by the Massachusetts League of Community Health Centers.

State Dues	\$200
District Dues	\$50-\$200

#### Senior

Physicians with five years or more of continuous membership at the time of request who are (a) age 65 and over and fully retired or (b) age 72 and over and working 20 hours/week or less.

State Dues	\$100
Hampshire District Dues	\$50
Worcester District Dues	\$75

#### Emeritus Free

Physicians with 25 years or more of continuous membership at the time of request who are (a) fully retired or (b) working 20 hours/week or less.

#### Life Memberships Call

Membership discounts based on age. Life members are enrolled in the Holyoke Society and receive a "Life Member" gold pin. Proceeds support the MMS and Alliance Charitable Foundation.

### Out-of-State and Military

<b>Out-of-State</b>	<b>\$175</b>
Save 61% and no district dues. If your membership lapses, and you rejoin while remaining out of state, you must do so within two years from the date your membership ended.	

### Active US Military Service Free

Free group membership when an entire training program enrolls.
